I understand that this Release covers liability, claims and actions caused entirely or in part by any acts or failures to act by the Tzu Chi, it’s Foundation, its Members, its Agents, including but not limited to negligence, mistake, or failure to supervise.

I recognize that this Release means I am giving up, among other things, rights to sue the Tzu Chi, it’s Foundation, its Members and its Agents for injuries, damages, or losses my minor child may incur while participating in the activities. I also understand that this Release binds my heirs, executors, administrators, and assigns, as well as myself and my spouse.
